



Use FIG. 4 as a guide for installing the solvent meter.

1. Perform the Pressure Relief procedure in the ProMix V Package Meter Proportioner Instructions manual. See **Related Manuals**, page 2.
 2. Perform the Shutdown procedure in the ProMix V Package Meter Proportioner Instructions manual. See **Related Manuals**, page 2.
 3. Install the solvent meter (101) beside meter B using the meter system bracket (111) and two hex head screws (107). See FIG. 4.
 4. Plumb the steel braided line (108) from the solvent meter (101) to the mix manifold. See FIG. 1 and FIG. 4.
 5. Plumb the customer supplied solvent supply to the check valve (102) on solvent meter (101). See FIG. 4.
 6. Attach the cable harness (106) and bulkhead cable (109) as shown in FIG. 4, then mount into the main enclosure.
- NOTE:** There can only be one flow meter per I/O module. Note how the A and B flow meters are plugged into I/O 1 and 2 in FIG. 4.
7. To install wires into I/O plugs, push the connector into place.

8. Mount the red line into the +24V line of the third or fourth I/O module, then mount the black wire into the ground of the same I/O module. See FIG. 4.
9. Mount the white line into an available I/O port, using the first of the series. For example, if port 2 is open, mount the white wire into 2.1, and 2.2 will be left empty. See the ProMix V Package Meter Proportioner Instructions for information on I/O allocation.

10. To enable the solvent meter:

- a. Navigate to the main screen using a tablet or computer, then log in.
- b. On the Home screen, make sure the control is OFF, as shown in FIG. 2.



- c. Navigate to the Settings tab, then navigate to the Hardware tab. Check any new hardware to enable. See FIG. 3.



